Aircraft equipment, designed and constructed to provide safe and secure carriage of cargo & baggage products during all phases of flight regardless of flight conditions, required to operate in accordance with the requirements of the aircraft Weight and Balance Manual.

Unit Load Device = Container or Pallet with net



# **Industry Contradictions**

#### Airline

- Responsible and Accountable to aviation authorities to use only airworthy ULD on all flights
- Responsible for the costs associated with maintaining ULD in airworthy condition

- Ground Handling Industry
  - Responsible to airline for providing ground handling facilities for ULD
  - Limited responsibility for the care of ULD
  - Limited financial/risk stake



### Relationships and Liaison with related industry

- IATA CARGO ULD Panel
  - Assist to Initiate, Update and Develop ULD Regulations Manual content
  - Embrace & Apply IATA ULD Regulations Standards with ULD CARE Membership
- IATA Ground Handling Council
  - Initiate and develop an ongoing liaison with IATA GHC such that ULDCARE can inform and influence the ground handling community in regard to best practices for ULD operations
  - Sync ULD Content in IATA Pubs based on IATA ULD Regulations Pub.


